CONSERVATION RATE INCREASE

The new rates will go into effect with your **December 2022 billing**. (Our last rate increase was May 2015)

To avoid late fees, please mail your payment at least five to seven business days before the due date specified on your bill. You may pay your bill in person at our office. To avoid disconnection and a \$50.00 processing fee, past due amount must be paid by 8:00 a.m. on the last Tuesday of each month. The office is open to receive payments Monday through Friday from 9:00 a.m. to 5:00 p.m. There is no unlocks after 5:00 p.m.
